IFS Tobin Data Maintenance Policy

1. IFS Tobin All Access Subscriptions

Subject to the applicable signed agreements between the customer and P2, IFS Tobin All Access (TAA) subscribers have 24/7 access to their subscribed IFS Tobin Products through the web-based IFS Tobin Data Portal, IFS Tobin REST API, or through third-party applications using the IFS Tobin Connect web service. Note: 24/7 access may be impacted by scheduled maintenance or temporary service disruptions.
